Important information regarding communications with shareholders by Bacanora Lithium plc (the "Company") - Consent to send or supply documents and information in electronic form

The Company has authority to use electronic communications to send or supply to shareholders statutory documents and other communications, such as the Annual Report and Financial Statements, Notices of Meetings (including annual general meetings of the Company) ("**Documents and Information**"), as its default method of publication.

The Company's chosen method of electronic communication of these Documents and Information will be via publication on its website at www.bacanoralithium.com/investor-relations/agm-documents/ (the "Website"). Reducing the number of communications sent by post will not only result in cost savings to the Company but also reduce the impact that the unnecessary printing and distribution of reports has on the environment.

However, if you wish to continue to receive hard copies of these communications, you must return the reply slip attached to the bottom of this letter and return it to our Registrars. **If you do not return this slip within 28 days from the date of this letter, we will assume that you have consented to Website publication of the Documents and Information and you will no longer receive hard copies in the post.**

We will notify you when the Documents and Information are available to access on the Website and we will provide you with:

- The address of the Website.
- The place on the Website where the Documents and Information may be accessed.
- Details of how to access the Documents and Information.
